This is an agreement between the Undersigned (or minor in my charge) and **907 Barrel Racers** (the Company).

Acknowledges that horseback riding is a dangerous activity and involves RISKS that may cause SERIOUS INJURY ND IN SOME CASES DEATH, because of the unpredictable nature and irrational behavior of horses, regardless of their sining and past performance.
Knowing these facts and in consideration of your acceptance of this form, I voluntarily assume the risk and danger of ury or death inherent in horseback riding activities. I hereby RELEASE, DISCHARGE AND PROMISE NOT TO SUE a Company, doing business under its own name or any other name and/or any of its owners, officers, employees, lents, sponsors and sanctioning organizations (hereinafter the "Releasees"), for any loss, liability, damage, or cost natsoever arising out of or related to any loss, damage, or injury (including death) to my person or property.
Release the Releasees from any claim that such Releasees are or may be negligent in connection with my riding perience or ability including but not limited to training or selecting horses, maintenance, care, fit or adjustment of saddle bridles, instruction on riding skills or supervising riding activities.
INDEMNIFY, AND SAVE AND HOLD HARMLESS the Company and its employees and agents from and against any ss, liability, damage or cost they may incur arising out of or in any way connected with ay event, my use of a horse and by equipment or gear provided therewith or any acts or omissions of employees or agents.
Agree to abide by and follow any instructions given or rules established by the Company or any of its employees, pents or volunteers with regard to my participation in any event, use of a horse or any equipment or gear provided erewith.
The Undersigned expressly agrees that the foregoing release and waiver of liability, assumption of risk, and indemnity preement is governed by the State of Alaska and is intended to be as broad and inclusive as is permitted by Alaska law and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, gality and enforceability of the balance of the Agreement shall not be affected or impaired in an way and shall continue in I legal force and effect.
Acknowledge that this document is a contract and agree that if a lawsuit is filed against the Company or its owners, ents, employees, judges or managers for any injury or damage in breach of this contract, the Undersigned will pay all torney's fees and costs incurred by the Company in defending such an action.
